7. I agree not to abuse or neglect the Adopted Animal, and I authorize the Guardian, at his/her sole discretion, to determine whether or not the pet has been abused or neglected.
8. I understand that any failure to perform the foregoing agreement will constitute a breach of contract. In the event of any such breach of contract, I authorize the Guardian to reclaim both possession and ownership of the Adopted Animal. _____
9. I agree to give the Guardian occasional visitation rights to ensure that the terms of this adoption agreement are being observed. _____
10. I agree to not physically alter above named animal. Physically altering is to include declawing (onychectomy and tendonectomy) of the cat. _____
11. I understand that the adoption donation is non-refundable under any circumstance. _____
